Past Events

The April 4th non-point dive was a non-dive. Once again the dive was cancelled on site at Flag rock in Plymouth where three and four footers were rolling in to the beach. Roy and Jean Chamberlain, along with John Blackadar, met for breakfast at the Bickfords in Kingston and then went to the dive site where they made the above observation.

The April 18th Point Dive was held at Marblehead Light. The divers met at Lincoln Landing for breakfast. Four divers went into the water: Roy Chamberlain, Marshall Reynard, Jeannine Fabian and Robert Spiker. The water temp at the surface was 43 degrees and dropped to 39 degrees at a depth of 36 feet. The visibility was about 10 feet.

John Blackadar reports that he has contacted the underwater rugby team about sharing some pool time with them to demonstrate and try out the Inspiration Rebreather system. They are agreeable to having the presentation. John reports that he is looking at a date in the Fall when school reopens after the Summer break. It will allow time to coordinate the program.

We received an update from Wally Westphal on the plans being made to have a Christmas party for the wounded and injured military personnel returning from Iraq. At this time it appears that the party will be held at the U.S.C.G. Station Boston. He states that they will be looking for volunteers to assist in different phases of the plans. The clubhouse cleanup is scheduled for Saturday, May 1st. Joe Geyer, the cleanup committee of one, is looking for a few good men and women to join him in sprucing up the clubhouse grounds and giving the clubhouse a good spring cleaning.

Night Dives. John Molis has accepted the responsibility to again run the night dives this year. The dives will be held on the 4th Tuesday of each month. The first night dive will be held on June 22nd. The divers will meet at Hewitt's Cove in Hingham at 6:30 pm. More information and directions will be available in next month's newsletter.

The non-point dive for May is set for Sunday, May 16th, and will be in Scituate at Strawberry Point. Breakfast will be at 8:00 a.m. at the Gannett Grill. Directions are as follows. If you are coming from the Quincy area take Rte. 3A and follow it into Scituate. At the large "Welcome to Scituate" sign, turn left. Follow the road thru the first set of lights and the Gannett Grill will be on your left. If you are coming from the North, take Rte. 3 South. Take exit 14 off the highway. At the end of the exit turn left. You will be on Rte. 228. Follow Rte. 228 to Rte. 3A. Take Rte. 3A until you come to the "Welcome to Scituate" sign. Turn right and pass thru the first set of lights. You will come to the Gannett Grill on your on your left. If you are coming up the highway (Rte. 3) from the South, get off at exit 12. At the end of the exit take Rte. 139 toward Marshfield. Follow Rte. 139 to Rte. 3A. Turn left on Rte.3A. Follow Rte. 3A until you come to the "Welcome to Scituate" sign. Turn right and proceed thru the first set of lights and you will come to the Gannett Grill on your left. Meet here.

The Point dive for this month is Sunday, May 23, 2004 and will be at Stage Fort Park in Gloucester. This is also the date for the Annual Bay State Council Treasure Hunt. 

The Department of Marine Fisheries has a public hearing on May 3rd at 7pm at the Mass Maritime Academy in Buzzards Bay and May 4th at 7 pm at the Gloucester High School in Gloucester. From the information it looks as if they are looking to put a bag limit on our lobster catch.

Here is how it reads exactly:

2. (e) Establish a recreational daily bag limit of 10 lobsters applicable to recreational lobstermen while fishing or while traveling to and from fishing grounds either

i. in the SoutheasternRecreational Lobster Area;orii. in all state waters

It appears that this applies to divers holding recreational lobster licenses.




