MARINE FISHERIES ADVISORY — DELAY <u>CONTINUES</u> IN THE MAILING OF NON-COMMERCIAL LOBSTER PERMIT RENEWAL

As noted on the website of the *Commonwealth of Massachusetts Division of Marine Fisheries* there continues to be "a delay in the printing and mailing of non-commercial lobster permit renewals this year due to the addition of a reporting requirement and supporting harvest map on the annual catch report." Originally, it was anticipated the 2008 renewals would be mailed by the end of February.

Within two hours, the newsletter was ready to be mailed.

APRIL 8th — BOARD OF DIRECTORS MEETING South Shore Neptunes Junior Membership

One topic discussed at the April Board of Directors Meeting was "Junior Membership".

Our Constitution and By-Laws, Article II – Membership, Section 2 states, "Any person who has not reached the age of eighteen (18) years, but is sixteen years of age or older, may be admitted as a *Junior Member* under the conditions set forth in section one of this article concerning parental approval. The *Junior Member* shall be entitled to all the privileges of regular membership".

The reference of parental approval expressed in *Section 1* states, "... as a condition precedent to consideration for membership, [the applicant must] satisfy the members that their parents or guardians have no objections to their being members by having the proper application forms, provided by the organization, duly notarized and signed".

Angelo Correnti prepared a list recommending new conditions governing *Junior Membership* in the *South Shore Neptunes*. The *Board Members* reviewed, discussed, and modified the list for a *South Shore Neptunes Junior Membership* to read as follows:

- 1. Age 10 to 17 years of age.
- No Junior Member can hold an Office, or be a member of the Board.
- 3. All Junior Members can only attend meetings with an adult.
- 4. No *Junior Member* will be able to vote on monetary decisions.
- 5. *Junior Members* must always be accompanied by an adult at all club dives and events.
- All Junior Members must abide with all club rules and bylaws.
- 7. Dues for *Junior Members* who are part of a *Family Membership* will pay \$20.00 a year.

If not part of a *Family Membership*, dues will be \$30.00 a year.

If any *Junior Member* maintains three consecutive years of membership, you will not have to pay initiation fees when you become a regular member at 18 years of age.

- 8. All Junior Members must pass a Board and Club vote.
- 9. All *Junior Members* wishing to scuba dive with the club must be certified to dive with the club.
- 10. Junior Membership counts towards Life Membership for all paid years.

These recommendations would be a ratification to our *Constitution and By-Laws*. It is a requirement of the *Board* to properly relay these recommendations to the membership in meetings and through other communications. This topic will be discussed in the *Regular Meetings* and included in *Soundings* in both May and June. In July, these recommendations will be voted upon, and, if accepted, will replace the existing *Constitution and By-Laws* governing *Junior Membership* in the *South Shore Neptunes*.

All members are encouraged to attend an upcoming club meeting to voice their opinion on these proposed recommendations.

APRIL 9th — BAY STATE COUNCIL MEETING

Twenty-five members of the BSC attended the second meeting of 2008. The meeting began with guest speakers from *The Polus Center for Social & Economic Development:* **Theresa** and **Robert Kane**. Theresa, *Ph.D.*, and *Chief Operating Officer* of the *Center*, explained how this organization is currently helping the Mosquito Indians of northeastern Nicaragua – a country far away, yet their problem is disturbing to any diver.

Nicaragua's largest export is coffee; lobster exporting (at \$40 million dollars a year), is second. 90% of the catch is exported to restaurants and supermarkets in the U.S. and Canada. To meet the catch demands, divers (usually inexperienced and illequipped), search the ocean floor for spiny lobsters at depths of 130 feet. Upon depleting their air supply, these divers panic, and race to the surface, resulting in decompression sickness, or "the bends". Trained divers understand if you descend 140 feet, and have 20 minutes of bottom time, you do not dive again for at least 12 hours. The Miskito divers make 18 to 20 dives each day, and, as a result of the bends, live a life with disabilities ... that is, if they survive.
